

A. Reading the Results

Various statistics regarding health status, education, mortality, crime, employment, and others have been collected to portray the current status of Hunterdon County residents. For all of the data provided, the most recent published data at the county or municipality level were used. For example, if 2006 data are available at the national and state level, but only 2005 data available at the county level, year 2005 data are utilized.

Definitions

<u>Age-Adjustment-</u> There are many characteristics that render a crude rate of little use, especially when comparing different populations. Therefore, age-adjusted rates offer a more refined measurement to compare experiences over geographic areas or periods of time.

<u>Crude Rates</u>- Generally defined as the total number of events divided by the total population at risk; then multiplied by 1,000, 10,000, or 100,000.


Incidence Rates- Rates per 100,000 population for the specified years.







Poverty Guidelines: is a version of the federal poverty measure. They are issued each year in the Federal Register by the Department of Health and Human Services. The guidelines are a simplification of the poverty thresholds for use for administrative purposes (Determining eligibility for certain federal programs).

➤ Programs using the guidelines (or percentage multiples of the guidelines) in determining eligibility include Head Start, the Food Stamp Program, the National School Lunch Program, the Low-Income Home Energy Assistance Program, and the Children's Health Insurance Program. Note that in general, cash public assistance programs (Temporary Assistance for Needy Families and Supplemental Security Income) do NOT use the poverty guidelines in determining eligibility. The Earned Income Tax Credit program also does NOT use the poverty guidelines to determine eligibility (United States Department of Health and Human Services, 2005).






H1: Blood Cholesterol Awareness







I12: HIV/AIDS Age Breakdown (as of December 31, 2005)







I14: Flu Immunizations





I15: Flu Immunizations - Respondents Age 65+









J3: Cancer Incidence Rates by Race/Ethnicity (1999 - 2003 Average)







K5: Late or No Prenatal Care - Year Comparisons














N1: Days of Smoking



N3: Stopped Smoking the Past 12 Months







P4: Total Arrests by Race (2005)









Q4: Drug & Alcohol Admissions by Gender (2005)









U. CONCLUSIONS

Areas of Strength

The following areas can be considered strengths for Hunterdon County. These are areas where Hunterdon County appears healthier, or fares better, than the New Jersey and/or national statistics.

- ➤ **Population with a disability:** The percentage of residents in Hunterdon County (age 5 and over) with a disability is 9.7%, which is below the 12.0% statewide and 14.8% nationally.
- ➤ **Family households:** The proportion of family households and households with married-couple families is higher in Hunterdon County than throughout the state of New Jersey and the country.
- Female householder, no husband present: The percentage of households with no husband/father present is 5.3% throughout Hunterdon County. This is well below the state (12.6%) and national (12.6%) percentages.
- ➤ Occupied housing units: The percentage of vacant, or unoccupied, housing units within Hunterdon County (3%) is less than the New Jersey (7.4%) and national (9%) percentages.
- ➤ **Divorce rate:** The divorce rate in Hunterdon County is 2.9, compared to 3.2 for New Jersey and 3.8 for the United States.
- **Poverty rates:** The average income in Hunterdon County, and in turn, the poverty rate, is significantly better than the New Jersey and national statistics.
- ➤ **Health Care Coverage:** The percentage change between 2003 and 2004 in the number of children receiving Medicaid was -1.5% in Hunterdon County and +2.0% throughout the state. Additionally, the percentage of uninsured in Hunterdon County is 4.6% compared to 14.4% statewide and 16% nationwide.
- ➤ **Unemployment rate:** The July 2006 unemployment rate for Hunterdon County was 3.9. This is below the New Jersey rate of 5.5 and the United States rate of 4.8.
- ➤ Educational attainment: There are more residents within Hunterdon County with college and advanced degrees compared to New Jersey and the United States. This pattern is also true for the percentage of Hunterdon County residents with at least a high school diploma as well.
- ➤ **Mortality rates:** The overall mortality rate for Hunterdon County is below the state and national mortality rates.

- ➤ **Blood cholesterol screenings:** When asked if they have ever had their blood cholesterol checked, 94.5% of Hunterdon County residents responded "yes." This is above the 77.4% nationally and 81.4% statewide.
- ➤ **Obesity:** The percentage of adults who are overweight or obese in Hunterdon County is below the New Jersey and National percentages.
- > STD rates: The percentage of all reported cases of STDs (late syphilis, gonorrhea, Chlamydia, etc.) in Hunterdon County is fewer than the New Jersey reported cases.
- ➤ **Prostate cancer rates:** The proportion of males with prostate cancer in Hunterdon County yields a rate of 146.2 compared to 161.2 throughout New Jersey and 199.7 throughout the country. The mortality rates, however, for prostate cancer in Hunterdon County do not significantly differ from the state and national rates.
- ➤ Lung cancer rates: The proportion of residents with lung cancer in Hunterdon County is 56.7 compared to 67.5 throughout New Jersey and 67.5 throughout the country. The mortality rates for lung cancer in Hunterdon County are also below the state and national rates.
- ➤ **Teen birth weights:** The proportion of teen births in Hunterdon County is 2.9 compared to 12.3 throughout New Jersey.
- ➤ **Prenatal care:** Hunterdon County mothers are more likely than mothers throughout the state to seek prenatal care.
- ➤ **Births to married mothers:** Fewer births in Hunterdon County are to unmarried mothers (8.5%) compared to throughout New Jersey (29%).
- ➤ Oral health: The proportion of adults who have been to the dentist in the previous year in Hunterdon County (82.3%) is above the percentage throughout the state (74.4%) and nationally (69%). Hunterdon County adults are also more likely to have had a teeth cleaning in the previous year.
- ➤ **Previous smokers who now do not smoke at all:** Among those who have smoked at least 100 cigarettes in their lifetime, 89.1% now smoke "not at all." That is compared to 52.9% nationally and 56.5% statewide.
- ➤ **Crime rates:** The overall crime rate in Hunterdon County is below the New Jersey crime rate.
- ➤ Mental health: Hunterdon County adults reported better mental health compared to adults throughout New Jersey and the U.S., according to the most recent BRFSS results for Hunterdon County.

➤ Environmental health: In general, the environmental statistics for Hunterdon County are superior to the statistics for the other New Jersey counties.

Areas of Opportunity

The following areas can be considered opportunities for Hunterdon County. These are areas where Hunterdon County appears less healthy, or fares worse, than the New Jersey and/or national statistics.

- ➤ **Angina or coronary heart disease:** According to the 2005 Hunterdon County BRFSS results, 7.4% of adults have been told they have angina or coronary heart disease. This is compared to 4.6% throughout the country.
- Age of those with HIV/AIDS: While the proportion of Hunterdon County residents with HIV/AIDS is below the New Jersey statistics, the average age of those with HIV/AIDS is younger in Hunterdon County. For example, statewide, 29% of those with HIV/AIDS are 50 or older compared to 15% in Hunterdon County. Conversely, the percentage under age 30 with HIV/AIDS in Hunterdon County is 18% compared to 7% statewide.
- ➤ **Hepatitis C:** When looking at the change in the percentage of Hepatitis C cases between 2004 and 2005, Hunterdon County saw a 12.3% increase, while the state observed a 24.2% decrease during the same time period.
- ➤ **Melanoma of the skin:** The rate for skin cancer in Hunterdon County is 25.5 compared to 16.6 throughout the United State and 17.7 throughout New Jersey. The mortality rate for skin cancer in Hunterdon County (3.6) is also above the New Jersey (2.6) and United States (2.6) rates.
- ➤ Childhood asthma admissions: When looking at the percentage change between 2001 and 2002 in the number of hospital admissions for childhood asthma cases, Hunterdon County saw a 12.9% increase while the state saw a 11.6% decrease.
- ➤ Attempts to quit smoking among current smokers: When looking at the percentage in Hunterdon County who smoke "every day" or "some days," 47% have stopped smoking for more than a day in the previous year. This is below the New Jersey (57.7%) and United States (55.2%) percentages.
- ➤ **Deaths to suicide:** The proportion of all deaths in 2003 attributed to suicide is 1.3% in Hunterdon County, compared to 0.1% throughout New Jersey.

Additional Areas of Difference

There are a number of areas within the profile where Hunterdon County differs from the state and/or national data. However, whether these areas are clear strengths or opportunities can be debated. For example, if fewer Hunterdon County children test positive for lead poisoning, that could either be a sign of fewer cases of lead poisoning or that the monitoring system is less aggressive. Additionally, some of these areas may be viewed as neither a strength nor opportunity, merely a characteristic within the county.

- ➤ 65 & Over population change: The growth in the 65 and over population between 2000 and 2005 is far greater within Hunterdon County than throughout New Jersey and across the nation.
- ➤ **Racial diversity:** Hunterdon County has a larger proportion of White residents and fewer minority populations compared to the proportions for New Jersey and the United States.
- ➤ **Marriage rate:** The marriage rate in Hunterdon County is 4.8 compared to 5.8 for New Jersey and 7.7 for the United States.
- ➤ Children receiving TANF, Free or Reduced lunches: When looking at the change between 2000 and 2004, the percentage of Hunterdon County children receiving TANF decreased by 26.8% compared to a decrease of 16.6% across the state. Additionally, during the same time period, the percentage change in the number of children receiving free or reduced school lunches was -5.2% in Hunterdon County compared to +1.9% throughout the state.
- ➤ Average travel time to work: The average travel time to work is 35.3 minutes for Hunterdon County employees. This is above the 29.5 minute and 25.1 minute averages for New Jersey and United States employees as a whole.
- ➤ **Birth rates:** The birth rate in Hunterdon County is 10.9 compared to 13.5 throughout New Jersey.
- ➤ Arrests between 2004 and 2005: Between 2004 and 2005, Hunterdon County saw a 5.4% increase in the number of arrests while the state of New Jersey saw a 0.3% increase. While the percentage of adult arrests was up during the same time period, the percentage of juvenile arrests decreased.
- > Substance abuse cases treated in county of residence: Nearly 70% of those in Hunterdon County who were treated in 2005 for drug and/or alcohol problems were treated within the county. This is above the 58% in New Jersey treated within their county of residence.
- ➤ **Drug admissions by primary drug:** The percentage of admissions in Hunterdon County for alcohol treatment is above the New Jersey statistics, but the percentage admitted for heroin and other opiates is lower in Hunterdon County than New Jersey.

Referral source for treatment: Hunterdon County abusers are more likely to have been referred for drug and/or alcohol treatment by a social agency and less likely to have been referred by the criminal justice system compared to New Jersey.
